Infinity Sedan & Coach is committed to providing you with the best possible travel experience. We will provide with requested vehicle in a professional manner and a highly trained chauffeur.

1. A Non-Refundable Deposit might be require at the time of booking reservation.
2. Credit Card information is required to reserve.
3. Cancellations are accepted by phone and email only. Emailed cancellations will be valid once Infinity Sedan has acknowledged such email. We require a minimum of seventy-two (72) hours notice prior to schedule pickup time in order to avoid late cancellation charges. (Some restrictions may apply) Please contact us for your particular cancelation policy.
4. All of our vehicles are non-smoking. Smoking tobacco or any other type of illegal drugs is prohibited.
5. Reservations exceeding scheduled length of time will be charged accordingly to final usage time. (And rounded up to next half hour)
6. Client shall not interfere with the Chauffeur in the discharge of his/her duty or tamper with any apparatus or appliance on the vehicle.
7. Client is responsible for his/her guest and their actions. Client assumes full financial responsibility for any damages to the vehicle or property caused by client or party whether by accident, neglect or intent. Client assumes responsibility for any overtime fees and authorizes to charge credit card on file to cover these costs or any others due and not collected at end of service. Sample damage charges are: Broken glassware - \$30 each; broken decanter - \$50; spills - \$35; cigarette smoke or burns - \$350 min.; vomit - \$200 min. Downtime for vehicle repairs - \$500/day. Any additional damages to interior or exterior of limo such as TV, VCR, Stereo, CD, etc. will be billed accordingly.
8. Our Limos are stocked with ice, bottle water and soft drinks. Client is welcome to bring own beverage.
9. Our company and chauffeurs assume no responsibility for articles left in vehicle. Infinity Sedan & Coach is not responsible for lost, misplaced or stolen items left in vehicle.
10. We reserve the right to refuse service. Illegal acts, unruly behavior or safety violations will result in immediate termination of service.
